Dear Mr. Gilbert M. Bankobeza,

The Committee of Environmental Protection under the Government of the Republic of Tajikistan presents its compliments to the Ozone Secretariat UNEP and expresses our appreciation for its continuous cooperation.

Please be informed that, in accordance with paragraph 3 of Article 7 of the Montreal Protocol, adopted at the meeting of the Parties (decision XXVII / 8), and on the basis of paragraph 5 of the Decree of the Government of the Republic of Tajikistan of November 2, 2015, No. 643, a ban has been established on the import of products and equipment containing ozone-depleting substances, included in List C (hydrochlorofluorocarbons) of the Montreal Protocol from January 1, 2017. On the basis of this Decree of the Government the import of these products into the Republic has been discontinued for the last two years.

In this regard, we ask you to include Tajikistan in the list of countries that have banned the import of equipment using HCFCs in accordance with Decision XXVII/8.

The Committee of Environmental Protection under the Government of the Republic of Tajikistan avails itself of the opportunity to renew to the Ozone Secretariat the assurances of its highest consideration.
