

Disclosure of Interest

(Shiqiu ZHANG, Peking University)

I, Shiqiu ZHANG, nominated by China, residing in China, a co-chair of the TEAP Decision XXXI/1 Task Force on the replenishment of the Multilateral Fund for the implementation of the Montreal Protocol (hereinafter referred to as the Replenishment Task Force or RTF) declare as follows:

- 1) I have read the Conflict of Interest and Disclosure Guidelines for the Technology and Economic Assessment Panel, its Technical Options Committees and Temporary Subsidiary Bodies (“the COI Guidelines”) as adopted by the Meeting of the Parties in Decision XXIV/8.
- 2) I am a Professor of Peking University, Beijing of China. My responsibilities include teaching courses and conducting research activities in the fields of Environmental Economics, environmental policy and governance.
- 3) This declaration constitutes my written agreement, pursuant to paragraph 8 of the COI Guidelines, to comply with the Guidelines. I understand that this written agreement is a condition of my service.
 - 1) My interests, and those of my personal partner and dependents, include the following
 - a. Proprietary interests: I *do not have* proprietary interest in a substance, technology or process to be considered by TEAP or any of its TOCs or temporary subsidiary bodies (e.g. task forces).
 - b. Financial interests: I *do not have* ownership, shares or bonds in an entity with an interest in the subject matter of the meeting or work.
 - c. Employment, consultancy, directorship or other positions: University activities and academic activities.
 - d. Government advice and other policy development: I do consultancy for national and local Governments on environmental pollution control and policy issues.
 - e. Paid research activities, fellowships or grants: I am not the recipients of any paid research activities or any fellowships or grants for work related to a proposed use of an ozone-depleting substance or an alternative to a proposed use of an ozone depleting substance.
 - f. Other interests:
- 4) The source of funding for my participation in the work of the TEAP RTF is on an entirely voluntary (unpaid) basis, Travel expenses associated with TEAP and task forces meetings are paid by UNEP, and sometimes by Peking University.
- 5) Pursuant to paragraph 11 of the COI Guidelines I declare that I [have][have not] declined to disclose information falling within paragraph 10 of those Guidelines [and I undertake to ensure that I am completely excluded from discussions and decisions

on topics related to the information that I have declined to disclose].

- 6) I undertake to disclose any material change to any of the above information, pursuant to paragraph 9 of the COI Guidelines, within 30 days of any such change.
- 7) I undertake to make further declarations of interest annually for so long as I remain a member of the TEAP RTF.
- 8) I understand that this DOI will expire no later than one year after I have signed it.
