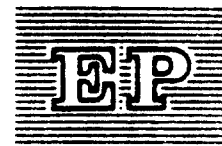

ANNOTATED PROVISIONAL AGENDA

1. Opening of the meeting

The second part of the third session will be opened at 10.30 a.m. on Monday, 16 January 1984 in the Vienna International Centre, Vienna.

2. Election of officers

The meeting will elect a chairman, a vice-chairman and a rapporteur.

3. Adoption of the agenda and organization of work

The meeting will decide on how the work of the second part of the third session should be organized. (It is suggested that the work of the meeting will normally be conducted in Plenary with provision for small working groups as necessary, it being understood that interpretation services are provided for one meeting at a time).

4. Consideration of a global framework convention and protocol for the protection of the ozone layer

The mandate of the meeting is laid down in part two, B.I. of Governing Council decision 11/7 of 23 May 1983 on programme matters. In accordance with this decision, the Executive Director convened the first part of the session of the Ad Hoc Working Group on 17-21 October 1983 and, following the latter's recommendations, a second part with a view to having the Working Group, if possible complete its work for transmittal through the Executive Director and the Governing Council to the General Assembly of the United Nations.
