I. Introduction

1. The Bureau of the Thirtieth Meeting of the Parties to the Montreal Protocol will meet at 4 p.m. on Sunday, 3 November 2019, in Rome at the headquarters of the Food and Agriculture Organization of the United Nations. The present note provides information on items 3 and 4 of the provisional agenda for the meeting (UNEP/OzL.Pro.30/Bur.1/1). Section II summarizes information on agenda item 3 on the actions taken by the Secretariat with regard to the decisions of the Thirtieth Meeting of the Parties. Section III provides information relating to the review of the agenda, the presentation of a road map and an overview of documents for the Thirty-First Meeting of the Parties.

II. Work to date on the implementation of the decisions of the Thirtieth Meeting of the Parties to the Montreal Protocol (agenda item 3)

2. The table set out in the annex to the present note provides a broad overview of the decisions adopted by the Thirtieth Meeting of the Parties and the actions required of and taken/to be taken by the Secretariat in response thereto.

III. Review of the agenda, presentation of a road map for the conduct of the meeting and overview of the working documents prepared for the Thirty-First Meeting of the Parties to the Montreal Protocol (agenda item 4)

- 3. The Thirty-First Meeting of the Parties to the Montreal Protocol will be held from 4 to 8 November 2019 in Rome at the headquarters of the Food and Agriculture Organization of the United Nations. In accordance with established practice, the meeting will be divided into two segments: a three-day preparatory segment and a two-day high-level segment. The preparatory segment is scheduled to begin at 10 a.m. on Monday, 4 November, while the high-level segment will begin at 10 a.m. on Thursday, 7 November. Online registration opened on 29 July and on-site registration will open on Saturday, 2 November.
- 4. The provisional agenda for the Thirty-First Meeting of the Parties (UNEP/OzL.Pro.31/1) was circulated to the parties in August 2019, and the annotations to the provisional agenda (UNEP/OzL.Pro.31/1/Add.1) will be issued in October. A note by the Secretariat (UNEP/OzL.Pro.31/2) provides background information on the issues on the provisional agenda. An addendum to that note is expected to be issued in October.
- 5. The above-mentioned documents, along with a number of other documents that provide detailed information on issues included in the provisional agenda, have been posted on the conference portal of the Thirty-First Meeting of the Parties (http://conf.montreal-protocol.org/meeting/mop/mop-31/SitePages/Home.aspx).
- 6. The provisional agenda for the preparatory segment includes all the issues that are expected to be taken up during the high-level segment for decision by the parties. To date, the Secretariat has not received any requests from parties to raise issues under agenda item 17, "Other matters".
- 7. With regard to budget-related issues, the Secretariat has prepared the proposed budgets of the Trust Fund for the Montreal Protocol for 2020 and 2021 (UNEP/OzL.Pro.31/4). There has not been any revision to the 2019 budget that was approved by the parties in 2018. Pursuant to paragraph 9 of decision XXX/20, the Secretariat has produced activity fact sheets, following a format similar to that used by the secretariat of the Basel Convention on the Control of Transboundary Movements of Hazardous Wastes and Their Disposal, the Rotterdam Convention on the Prior Informed Consent Procedure for Certain Hazardous Chemicals and Pesticides in International Trade and the Stockholm Convention on Persistent Organic Pollutants, on its areas of work for 2020 and the related activities to be carried out (see UNEP/OzL.Pro.31/INF/1, annex). A financial report for the trust funds for the Vienna Convention for the Protection of the Ozone Layer and for the Montreal Protocol for fiscal year 2018 has also been prepared for consideration by the parties (UNEP/OzL.Pro.31/5). A budget performance report for 2019, as at 30 September 2019, is presented as an information note (UNEP/OzL.Pro.31/INF/2).
- 8. A note by the Secretariat and an addendum thereto (UNEP/OzL.Pro.31/2 and UNEP/OzL.Pro.31/2/Add.1, respectively) summarize the issues on the provisional agenda for the Thirty-First Meeting of the Parties. The note provides an overview of all issues covered in the provisional agenda of the preparatory segment, including the terms of reference for the study on the 2021–2023 replenishment of the Multilateral Fund for the Implementation of the Montreal Protocol; potential areas of focus for the 2022 quadrennial assessment reports of the Scientific Assessment Panel, the Environmental Effects Assessment Panel and the Technology and Economic Assessment Panel; unexpected emissions of trichlorofluoromethane (CFC-11); ongoing reported emissions of carbon tetrachloride; issues related to exemptions under Articles 2A–2I of the Montreal Protocol, namely, nominations for critical-use exemptions for methyl bromide for 2020 and 2021, stocks of methyl bromide, development and availability of laboratory and analytical procedures that can be performed without using controlled substances under the Protocol, and process agents.
- 9. Other topics on the provisional agenda for the preparatory segment relate to the access of parties operating under paragraph 1 of Article 5 of the Montreal Protocol to energy-efficient technologies in the refrigeration, air-conditioning and heat-pump sectors; terms of reference, composition, balance, fields of expertise and workload of the Technology and Economic Assessment Panel; membership of the Executive Committee of the Multilateral Fund; a request by Azerbaijan to be included among the parties to which the phase-down schedule for hydrofluorocarbons, as set out in paragraphs 2 and 4 of Article 2J of the Montreal Protocol, applies; safety standards; an initial assessment by the Scientific Assessment Panel and the Technology and Economic Assessment Panel of five volatile fluoroorganic and related compounds found in the Arctic; the consideration of

nominations to the assessment panels; compliance and data-reporting issues: the work and recommended decisions of the Implementation Committee under the Non-Compliance Procedure for the Montreal Protocol; the risk of non-compliance with hydrochlorofluorocarbon reduction targets for 2019 by the Democratic People's Republic of Korea; and the status of ratification of the Kigali Amendment to the Montreal Protocol.

- 10. A list of the working and information documents that will be available for the Thirty-First Meeting of the Parties, along with background information, may be found in document UNEP/OzL.Pro.31/INF/8.
- 11. In accordance with established practice, the Co-Chairs of the Open-ended Working Group will oversee the preparatory segment of the meeting. After the opening of the high-level segment, the parties may reconvene the preparatory segment as they deem expedient to allow for the completion of any unfinished business.
- 12. The opening of the high-level segment on 7 November will be chaired by the President of the Thirtieth Meeting of the Parties, who will conduct the meeting until the parties elect the president of the Thirty-First Meeting of the Parties. In accordance with rule 21 of the rules of procedure for Meetings of the Parties to the Montreal Protocol and the established practice of rotating the posts of president and rapporteur among the regional groups in English alphabetical order, it is expected that the President of the Thirty-First Meeting of the Parties will be elected from among the Latin American and Caribbean States, the Rapporteur from among the Eastern European States and the three Vice-Presidents from among the African States, Asia-Pacific States and the Western European and other States. The newly elected President will then guide the parties through the agenda, on the understanding that the work of contact groups established during the preparatory segment may continue in parallel with the high-level plenary sessions in an effort to resolve any outstanding issues by Friday, 8 November 2019, when the parties are expected to adopt draft decisions.
- 13. The Ozone Secretariat, in cooperation with the Government of Italy, will organize a high-level round-table discussion during the high-level segment under item 5 of the provisional agenda for that segment, "Statements by heads of delegation and discussion on key topics". The round-table discussion will address the contribution of the Montreal Protocol to the development of a sustainable cold chain to reduce food loss. The concept note and provisional agenda for the round-table discussion are set out in document UNEP/OzL.Pro.31/INF/7.
