**Addendum****I. Introduction**

1. The present addendum to the note by the Secretariat on issues for discussion by and information for the attention of the Sixth Extraordinary Meeting of the Parties to the Montreal Protocol on Substances that Deplete the Ozone Layer presents new and updated information that has become available since the preparation of that note (UNEP/OzL.Pro.ExMOP.6/2), in particular regarding item 3 of the provisional agenda on membership of the Implementation Committee for 2026. The information is set out in section II.

**II. Membership of the Implementation Committee for 2026 (item 3 of  
the provisional agenda)**

2. On 25 June 2026, the Secretariat received a note verbale dated 24 June 2026 from the Permanent Mission of the Russian Federation to the International Organizations in Nairobi, informing the Secretariat of the self-nomination of the Russian Federation to the seat for the group of Eastern European States in the Implementation Committee under the Non-compliance Procedure for the Montreal Protocol. The note verbale states that the nomination is for elections to be held during the Sixth Extraordinary Meeting of the Parties.

3. On 1 July 2026, the Secretariat received a note verbale dated 30 June 2026 from the Embassy of the Czech Republic in Nairobi, informing the Secretariat of the self-nomination of Czechia to the seat for the group of Eastern European States in the Implementation Committee under the Non-compliance Procedure for the Montreal Protocol. The note verbale states that the nomination is for elections to be held during the Sixth Extraordinary Meeting of the Parties.

4. As is mentioned in paragraph 18 of the note by the Secretariat (UNEP/OzL.Pro.ExMOP.6/2), an information note summarizing the situation of the membership of the Eastern European Group was made available for the forty-eighth meeting of the Open-ended Working Group of the Parties and the Sixth Extraordinary Meeting of the Parties (UNEP/OzL.Pro.WG.1/48/INF/4–UNEP/OzL.Pro.ExMOP.6/INF/1).
